



# Memorandum of Agreement Between Hawai`i Community College and Chaminade University of Honolulu

This Memorandum of Agreement is entered into by and between Chaminade University (hereinafter referred to as CUH) and Hawai'i Community College (hereinafter referred to as HawCC) to establish guidelines for a 2+2 pathway leading to a baccalaureate degree at CUH. Both parties are entering into this agreement to coordinate and expand the undergraduate trajectories of students in the pathway outlined in this document.

This document describes eligibility requirements for Hawai'i Community College (HawCC) graduates to enter a two-year program of study at Chaminade for degree completion and award of a Chaminade University (CUH) Bachelor's degree. The eligibility requirements and resulting two year plan reflects the careful course equivalency analysis and approval of the respective Dean, program faculty and the Vice Provost for Academic Affairs. The pathway is designed as a program-to-program approval, in that meeting the eligibility requirements elaborated below enters the students into the two-year plan, and individual transfer equivalencies are not evaluated on a course-by course basis. The plan reflects a complete General Education waiver for students entering CUH with an Associate of Science degree. Associate of Applied Science degrees do not meet the requirements for General Education waivers. Both HawCC and CUH agree to review the agreement every two years in order to support the transfer, matriculation, and graduation of students from both HawCC and CUH.

General CUH admission policies, fees, and other CUH polices are outlined in the <u>CUH Catalog</u>. A credit transfer guide for students outside the pathways can be found <u>here</u>.

#### **Criteria for 2+2 Completion**

Completion of the AS at HawCC as outlined in the specific pathway outlined below enables HawCC transfer students to waive the Chaminade General Education requirements. Students transferring into CUH for the degree pathway specified below should take the courses identified for the specific pathway at HawCC prior to transfer to CUH in order to meet the two-year degree completion timeline at CUH. All CUH admissions criteria otherwise apply, as noted in the <u>CUH Catalog</u>, updated annually.

#### Marketing

Both schools will independently, and when feasible, jointly, market the pathways. Sources include school website, publications, posters, and recruiting.

### Term

This Agreement will be effective from July 1, 2022, through June 30, 2027. The Agreement will be reviewed annually by both parties during this five-year period. Termination of this Agreement, by either party, must be accompanied by written notification three months in advance of their intent to terminate.

#### Amendments

Both parties agree that any amendments to this Agreement, other than termination, shall be mutually agreed on in writing thirty days prior to the effective date before being undertaken.
